	As the Interim President, Muriel made the welcome and explained briefly the purposes	
	of the Unit and the outcome of recent elections:	
	a) Purposes - As stipulated in the Unit 255 draft by-laws, the purposes for which the Unit is organized are: to foster community welfare in the furtherance of the game of contract bridge in its various forms of competition; to promulgate high standards of conduct and ethics to its members, and to enforce such standards; to provide organized bridge activities and services to satisfy the social, recreational, and competitive needs of the membership and the community; to promote and support the ACBL education program; to conduct tournaments and other competitive events as permitted by the American Contract Bridge	
	League (ACBL); and to conduct such other activities as may be in keeping with its principal objectives.	
	b) Board Elections - There were 5 nominations for 4 elected board positions. As Wiebe withdrew his nomination, other 4 members who were nominated (Muriel Tremblay, Kathy Morrison, Chris Loat and Chandi Jayawardena) were acclaimed to the Unit Board. In order to maintain continuity, 2 of these acclaimed directors will have to commit to stand for three years until May 2021,	
	while the other 2 will serve the normal term of 2 years until May 2020. This will	Muriel

Other 3 Board positions were filled by the 3 nominees from the Boards of Bridge Centre of Niagara (Wiebe Hoogland), and Camelot Bridge Club (Elinor Grill) and NOTL Duplicate Bridge Centre (Lucy McEwen). These 3 directors were appointed for a term of office of 2 years up to May 2020.
